**1** **Date:** 23 Nov 2016  
**Location:** 404 South 6th Street  
**Who:** Thomas Brown, Kaleb King, Christian Webb

*Thomas meets his friends at the carpark of the Canadian Middle School*

**2** **Date:** 23 Nov 2016  
**Location:** Various; stop at Canadian Wagon Bridge  
**Who:** Thomas Brown, Kaleb King, Christian Webb

*Thomas leaves his car in the carpark; as does his friend Kaleb King. Christian Webb drives them in her car. They drive around town. One place where they end up to go for a walk is the Canadian Wagon Bridge*

**3** **Date:** 23 Nov 2016 / 11:26 pm  
**Location:** 404 South 6th Street  
**Who:** Thomas Brown, Kaleb King, Christian Webb

*They decide to call it a night and return home shortly after 11 pm. Christian drives Kaleb and Thomas back to the Canadian Middle School. They all leave the carpark in their cars separately. Thomas leaves at 11:26 pm*

**4** **Date:** 23 Nov 2016 / 11:28 pm  
**Location:** 718 South 2nd Street  
**Who:** Thomas Brown

*At 11:28 pm Thomas arrives at Fronk Oil*

**5** **Date:** 24 Nov 2016 / approx. 12:13 am  
**Location:** 1513 Locust Street (Wildcat stadium)  
**Who:** Thomas Brown

*Just after midnight, Tom's phone sent out its final ping*

**6** **Date:** 24 Nov 2016 / 01:30 am  
**Location:** Corner of North 2nd Street and East Main Street  
**Who:** Thomas Brown

*About 1:30 am a car matching Tom's is captured on footage driving past the Abraham Investment company*

**7** **Date:** 24 Nov 2016 / 05:24 am  
**Location:** South 2nd Street & West Main Street  
**Who:** Thomas Brown

*Tom's vehicle is captured travelling north on 2nd Street, then it turned East up Main Street*

**8** **Date:** 24 Nov 2016 / 05:28 am  
**Location:** East Birch Street & South 2nd Street  
**Who:** Thomas Brown

*At 5:28 am Tom's car is seen heading south on 2nd Street before turning east on Birch Street. (Captured on footage from Alexander's Grocery & Deli)*

**9** **Date:** 24 Nov 2016 / around 05:29 am  
**Location:** East Birch Street & South 2nd Street  
**Who:** Thomas Brown

*Just over 1 minute later the car is seen travelling west on Birch Street before turning back onto 2nd Street and heading north – it drives back past Alexander's Grocery & Deli*

**10** **Date:** 24 Nov 2016 / around 05:56 am  
**Location:** North 6th Street  
**Who:** Thomas Brown

*At 5:56 am Tom's car is captured on footage from the Hemphill County recreation centre. It turns off US route 60 (North 2nd Street) and heads east on 6th Street. It enters the wastewater area, drives up a small hill, parks in a remote area on the downside of the hill, underneath trees – about 500 yards from the Oasis Cove Apartments complex. The car is abandoned here*

**11** **Date:** 24 Nov 2016  
**Location:** North 6th Street  
**Who:** ----

*No sign of Tom. He was never seen again. Bloodhounds called in tracked Tom's scent 1200 metres east from where his car was found – to the Canadian River. They lost his scent when they hit got to the marsh/ water area of the river*

**12** **Date:** 27 Jan 2017  
**Location:** Lake Marvin Road / 2266  
**Who:** ----

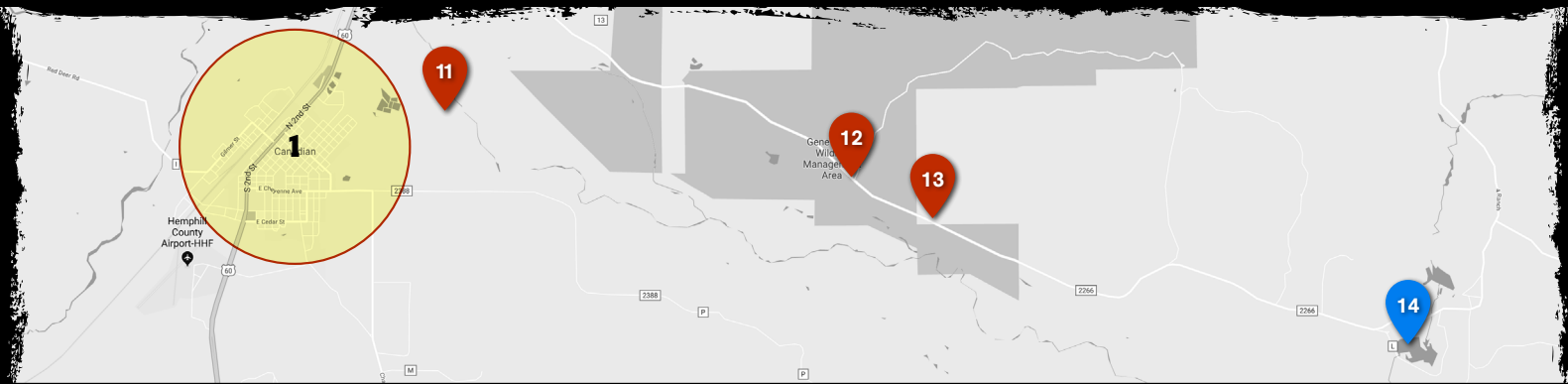
*Tom's missing backpack was found 3.8 miles due east from where his vehicle was discovered, following along the same direction from where the dogs lost his scent. Precise location not know; however it was along the Lake Marvin Road, on the northern side of the road. Spotted in a small grove of trees behind a barbed wire fence*

**13** **Date:** Nov 2017  
**Location:** Lake Marvin Road / 2266  
**Who:** ----

*An iPhone 6s possibly belonging to Tom was found along Lake Marvin Road 10 months after his backpack was located. Precise location not known*
